- 7. Appointment of Life Membership

Graeme Pickering was nominated for Life Membership at the recent Executive Committee meeting on 31st May, 2016. He was then voted unanimously for life membership and becomes the 13th Life Member of MWTA. A formal presentation will be made in Port Macquarie in December at State Cup 2016 presentation dinner.

9. Notice of Motion regarding Special Resolution to Amend the Constitution.

It was identified that the Constitution currently being used as from 1974 is no longer relevant in some parts to our Club today. So in consultation with a solicitor and NSW Touch, we created a new Constitution to better serve the needs of our current members. The main changes had to do with the definition of different types of members along with quorums. Jim Bennett noted that he read the new Constitution twice through and it was well thought out and thorough. It was voted unanimously to adopt the new Constitution in replacement of the old one.

Ian Kalms recommended that we continue to use the services of Kristin Patrick as our auditor and this was agreed unanimously.

12. General Business

Graham Knights explained that MWTA has a handshake agreement in place with Christian Brothers to have use of the clubhouse at Nolan Reserve for the summer touch season, starting in September. We will be investing some money into the clubhouse to upgrade it for our use. Peter Casey noted that from his past experience, touch players don't usually go for drinks after their game so the bar will not be supported. Stuart Edgley commented that the bar aspect of getting the clubhouse is low on our list of priorities at the moment, and the clubhouse is more a place for MWTA to call home. A place for trophy cabinet to display our silverware, somewhere to hold meetings along with the potential for a much better canteen for the Friday junior competition. Peter Casey also enquired about other possibilities for a clubhouse such as one being built by the Council at Nolan Reserve, and Stu Edgley explained that he and Graham Knights had looked into that option but it would be a few years off, and that using and upgrading the existing Christian Brothers clubhouse was our best option. Graham Knights also told everyone that the scoreboard that was recently purchased will soon be mounted on the side of the clubhouse building permanently.

Meeting declared closed at 7:50pm.

President's Report 2016/17

It has been another challenging but successful year for the Manly Warringah Touch Association. Our executive and general committees have been very busy again this year. Every position on both committees were filled by fantastic and proactive members.

This year has seen some significant changes in the structure of the administration of the club. Jill Zochling, who has worked for the club as the Administration Manager for 2 years, decided to move on due to being offered a full-time job locally. Jill did a fantastic job running the administration of the club and was a big part of the success of the junior local competitions, she will be sadly missed. The good news however, is she will continue in her role of junior competition referee coordinator.

With the Administration Manager role vacant, the MWTA Executive Committee saw an opportunity to create an administration role that looks after all administration of the club. The Executive Committee created a job description merging the Competition Manger administration tasks with the new Administration Manager role. This new role includes the running of competitions including creating draws, entering results, looking after team uniforms orders, general competition inquiries, liaising with council, liaising with NSWTA, and many more tasks. The position was advertised and Lara Long was appointed the new Administration Manager of MWTA. This will now create more free time for the Executive Committee to attend to the many projects that we just didn't get the opportunity to manage in the past. We endeavour to have some of those tasks completed in the coming 12 months to further advance our club.

At last year's Manly Warringah Touch Association Annual General Meeting, Grahame Pickering received life membership into the Manly Warringah Touch Association. This a great reward for the countless volunteer hours that Picko has put into our club. Congratulations to Picko and a big thank you from everyone at Manly Touch for everything you have done for our club over the many years.

Dee Why RSL club continued its great sponsorship of our club. They are the MWTA platinum sponsor and have been now for many years. Doyle Spillane Real Estate continued to support MWTA. Geoff Harris at Doyle Spillane is a valued active member of the club and its through his connections that the relationship continues.

Our junior competition smashed records yet again. This year we had 235 teams register for the Summer Junior Competition and 73 for our Junior Shot Gun competition. Both competitions have seen massive growth yet again. The atmosphere at Nolan reserve North manly on a Friday afternoon is just awesome and I am sure I am not the only one who really looks forward to each Friday afternoon of junior touch football. Our senior local park competitions continued to improve both on and off the field. Numbers have remained steady but the level of touch football within the local competitions continues to advance. Our Men's A competition had 9 teams in the summer competition and this is the largest number for many years. This score board that was purchased last season has now been mounted onto the side of the Christian Bros club house and is a fantastic addition to our local competitions. You always know when games have started due to the audio of the siren and the visual of the clock counting down.

Our relationship with Christian Bros Rugby League club continues to be strong. We have use of the clubhouse throughout the summer season. Christian Bros use the score board for their home games and having been down at a Christian Bros home match on a Saturday evening just recently, the atmosphere was extremely enjoyable. The Christian Bros club have a very similar mindset as MWTA as being a club for the families. The spectators and players seem to enjoy having the scoreboard up and running and it has given the games a new level of professionalism.

Our representative teams continue to dominate. We are both Senior and Junior State Champions. I will not go into detail about them in the report but I will leave that to the Senior and Junior representative directors reports.

I would like to thank all of the members of the executive and management committees of MWTA. We currently have a great bunch of active committee members that are really helping to maintain MWTA as the best touch football club in Australia. I look forward to another year of success for our great club.

Treasurer's Report 2016/17

It is with great pleasure that I present a summary of the 2016-17 financial year to the members of the Manly Warringah Touch Association Incorporated (MWTA).

Following this report is a copy of the MWTA Financial Statements for the Year Ended 31 March 2017. Please also refer to the 2016-17 MWTA Financial Report.

Strategic Financial Intent

The MWTA Executive Committee will follow the ongoing strategic financial intent of Touch Football Australia, which is to maintain leadership in all aspects of best practice financial management in order to respect and deliver their Economic Mission:

To preserve the ongoing economic viability of the organisation, while ensuring the financial accessibility of the sport of Touch Football remains.

Financial Highlights

MWTA has had another strong year with an increase the number of teams and players participating in our touch football competitions (particularly in the juniors where we are near maximum capacity):

Operating Result

MWTA achieved a net profit of \$19,934 for the financial year ended 31 March 2017 which covers a 15month period from 1 January 2016 to 31 March 2017.

The operating result for 2016-17 reflects MWTA's operations in the reporting year, which accounts for the delivery of the sport of touch football for both recreational and representative players in the Manly Warringah region of Sydney.

The MWTA Accounts are prepared in such a manner that each of the junior and senior, summer and winter competitions and State Cup and Vawdon Cup representative competitions can be tracked to ensure that they each 'pay their own way' for example local competition recreational players are not subsidising our representative teams.

During the financial period the MWTA Executive Committee decided not to increase competition fees in 2016-17 due to the very positive results from the previous financial year. Therefore, MWTA absorbed all increases in the costs of running the various competitions such as ground hire, lighting, NSW touch affiliation fees and other general operating expenditures.

Performance Driven Financial Outcomes

The MWTA Executive Committee has implemented, and continues to review a number of strategies to ensure that the organisation remains in a position financially and resourcefully to respond quickly to all influences and economic pressures. The financial resilience of MWTA continues to be evident.

Significant Events

There are currently no commitments to purchase or lease equipment or property. There are also no unresolved issues that may create a liability for MWTA in the future.

Historical Financial Synopsis

MWTA uses the Cash Accounting Method.

Historically the MWTA financial year has been 1 January to 31 December. However, notice was given to all Members at last year's AGM to alter the financial year end from 31 December to 31 March. This formed part of the Notice of Motion re Special Resolution to amend the Constitution.

This amendment was due to several reasons:

- 1. MWTA financial accounts can be very misleading in particular the overall financial result when making comparisons year to year. This was mostly driven by the timing of both Senior State Cup (December) and Junior State Cup (February) on either side of our financial year end which caused problems in allocating the income and expense to the correct event and in the correct financial period. When invoices are presented they are paid based on requested supplier time frames and reported in that period even if they may relate to another financial period. Currently 33% of the Association's income is delivered across this period; therefore, these inconsistencies make year to year comparisons for the Executive Committee and members of the MWTA association difficult.
- 2. March and April are traditional down periods of MWTA with no major events being held, only the commencement of the Senior Winter Competition in April. However, by the end of March all team fees should have been paid up for the Winter Competition so there is very little in the way of income or expenditure being incurred in the month of April. This makes 31 March a more appropriate time for our financial year end.
- 3. There are no implications for MWTA, other than the accounts for this Financial Year cover a 15month period i.e. 1 January 2016 to 31 March 2017

A summary of our Net Profit results over the last three years show the volatility of our results.

Our reporting year is now 1 April to 31 March with the current new 12-month financial year coming into effect from 1 April 2017. This will now provide the Executive Committee consistency and surety in financial decision making and projections

Accounting Practices

Care Accounting are our Bookkeepers and provide for all our accounting needs.

As of 1 January 2016, MWTA have moved their financial accounting operations from MYOB to Xero. The Xero program is a cloud-based package that enables the MWTA Executive to review the accounts without the continual need to contact Care Accounting.

MWTA is a NSW Tier 1 Incorporated Association and is required to have its accounts audited. The financial statements must, at a minimum, comply with the requirements of Schedule B of Class Order No. 11/01.

Unfortunately, members will not be presented with the 2016-17 audited financial accounts due to timing issues. Whist the figures will remain very similar, in the interests of good governance a copy of the Audit Report and Audited Financial Accounts will be made available to all members on completion. These audited financial accounts will be available for inspection at no charge.

The 2016-17 audit will be conducted by Mr Jack McCann (BA CA CPA JP Director). Jack is an ASIC registered Auditor and Super Fund Auditor as well as a licensed Financial Advisor and Tax Agent. I recommend that Mr McCann be appointed auditor for the 2017-18 financial year as well.

Commercial Partners

To all of our commercial partners we thank you for your continued support. We particularly would like to mention Dee Why RSL - we would not be able to achieve the financial success and participation goals without their continued support.

Volunteers

Thank you to all the volunteers who turn up rain, hail or shine to continually represent MWTA. This includes our coaches, managers and members of our Executive Committee (President, Vice Presidents and Secretary) and also our Management Committee (Junior and Senior Representative Directors, Referee's Director, Merchandise Managers, Accommodation Managers, and those who donate their time to work on the BBQ and in the Canteen etc). While it can sometimes be a challenge, we thank you for your continued commitment to our great club. Once again we would not be able to achieve the financial success without your valuable un-paid contribution.

Summary

A surplus for the 15-month financial year of \$19,934, or 3% of income, is appropriate for a local community based sporting association and a Not for Profit Organisation.

Moving forward we will not experience the past problems of matching of income and expenditure for the financial period and will therefore have the ability to compare year to year performance more accurately.

MWTA is in a very stable position with no foreseeable change. This strong result will provide us with the opportunity for several programs, initiatives and capital expenditures in 2017-18 that will benefit all MWTA members.

The MWTA Executive Committee will continue to manage member funds in a diligent and professional manner and provide such stewardship in order to promote and foster the sport of Touch Football for both recreational and representative players in the Manly Warringah area.

Junior Representative Director's Report 2016/17

Our Junior Representative season started with a fantastic number of players trialling for our rep team. making it very hard for our selectors. We had 92 girls in the under 12's age group alone vying for 14 spots. This year NSW Touch decided to not allow our development teams to play at State Cup, as a result we entered ten representative teams at the NRL Junior State Cup.

However, with such a strong contingent of young players and wanting to maintain our development of our young players, we selected an additional 8 teams from the 10 - 16 year old age groups and created a development pathway for those teams through the season, including skill development and tournaments. Our first tournament was at the Northern Beaches Renegades Gala Day, with all 18 teams entered. It was great to see how competitive our development teams were with many wins throughout the tournament.

The A Teams backed up the following day at the Central Coast Touch Football Championships, where all or our teams performed well. Once again Manly won the Club Championship. We followed up with some more great results at both the Parramatta Gala Evening and the Scorpions Tournament, hosted by Manly.

Part of our development pathway this year for development teams was to enter those teams at the two day Peter Wilson Memorial Tournament hosted by The Hunter Western Hornets in early February. This is the second largest club tournament in NSW and our development teams all made it through the round games into the quarters, with our under 12 Girls going down by one try in the final. This was a fantastic weekend, with the same feel of a State Cup. We are already preparing for the same tournament next year.

Our ten A teams all turned up at Port Macquarie in February for another tilt at the club championship Junior State Cup. We had many fantastic results across all age groups and all teams made it through the rounds to the finals. We congratulate all teams who competed and congratulate our Under 14 Girls and Boys and Under 16 Girls teams, who all finished the weekend as champions. Once again Manly was awarded the prestigious club championship.







This year the committee employed the services of a professional cameraman to film the entire weekend for a promotional video. This is available on our Facebook Page and has been watched more than 12,000 times. This is yet another initiative that will reap fantastic rewards for our growth, over the years to come. As a testament of our great results at State Cup, Manly had an impressive number of players selected to play for the Sydney Scorpions at the NSW Regional Championships held in Ballina. Congratulations to our Coaches, Keith Smith, Tearoha Paki, Kalani Duff, Anthony Dudeck and Brandon McDonald, who all coached winning teams and helped the Sydney Scorpions win the Title for yet another year.

We also congratulate our junior players who represented NSW, Sydney Scorpion and Australia at the various representative tournaments over the last six months. Referee Director's Report 2016/17

The success of the MWTA representative teams continues to ensure there is always a demand for referees at both local competitions and at representative level. At our local competitions numbers of referees supporting our senior competition is unpredictable. Although the increase to referee payments has seen a sudden burst of interest in officiating.

Our junior competition is flourishing with 35 referees put through their level 1 course, most of whom will be supporting our junior competition. Unfortunately, this does not ensure ongoing numbers into our senor competitions as there remains a great player base where most of our junior referees get absorbed into our senior playing ranks. Here the Duty referee system is invaluable in providing officials on games and highlighting to some the challenges of refereeing.

The last 12 months has seen an increase in our MWTA referees successfully obtaining their Level 2 refereeing accreditation, with the majority being awarded at State tournaments.

With the minimum requirement being a level 2 accreditation for tournaments, we are in a better position to supply 100% home grown referees at our junior tournaments, but unfortunately at senior tournaments our club referee limitations are reflected in our heavy reliance on the extended touch referee community. Our recent Junior State cup saw our representative referees increase with the inclusion of Archie Simons, Isaac Morrell and Cliff Lyons, all of whom successfully obtain a Level 2 referee upgrade.



Due to the changes in club submissions for Junior State Cup, MWTA's approach to send our development teams to Peter Wilson Memorial tournament also allowed MWTA to introduce a new group of referees to tournaments. Here it was noted that the quality of our referees was high, and hopefully such events will allow us to support our referees into representative refereeing.

The MWTA executive are placing value on our referees and have been financially supporting Level 2 and above referee courses. This has also been extended to all our senior duty referees to ensure MWTA has badged referees on all its games.

Congratulations to Craig Hughes who was recognised at the NSW State Cup MWTA club dinner for his years of service to our sport at both local and representative level.

Caren Friend was recently appointed to the NSW referee coaching panel, a position that ensures MWTA will remain current in trends of the game.

The MWTA Referee Panel would like to acknowledge the referee coordinators at both our Senior and Junior competitions for the frontline work they are doing with the competition manager to ensure the success of our local competitions.



The MWTA referee panel continues to support the transition of our referees into our senior competitions, through coaching, course provision and mentoring through our development pathways. The goals set by this committee rely heavily on support of the players and our executive to assist in a sustainable competition.

We wish to thank the MWTA executive for supporting our initiatives to provide quality referees in an outstanding competition of high quality.
